

### Local Summary

**Over the last 12 months** the average rent achieved for homes let in Abingdon was £1,427 per month. This is a -1% change on the previous 12 month period.

40% of homes let in the past 12 months were flats, achieving an average rental value of £1,115 per month. Houses achieved an average rent of £1,628 per month.



## National Market

### Rental market

Average void periods shortened from 24 days in January to 20 days in February (Goodlord).

Rents are forecast to increase by 3-4% over 2025 as slower growth in large cities is offset by faster growth in more affordable markets (Zoopla).

The average rent in February was £1,275, up 1.0% year on year (HomeLet).

### Economy

The Bank of England have held interest rates at 4.5% in its second meeting of the year, amid persistent inflation.

Monthly GDP is estimated to have fallen by 0.1% in January 2025, after growth of 0.4% in December (ONS).

CPI inflation rose by 2.8% in the 12 months to February, down from 3.0% in January (ONS).

## ABINGDON GROSS YIELDS


OVER THE LAST 12 MONTHS AVERAGE
