

### Local Summary

**Over the last 12 months** the average rent achieved for homes let in High Wycombe was £1,367 per month. This is a 11% change on the previous 12 month period.

57% of homes let in the past 12 months were flats, achieving an average rental value of £1,174 per month. Houses achieved an average rent of £1,697 per month.

17% of renters are aged between 40 and 49.



## National Market

### Rental market

The average void period lengthened in October, rising from 16 days in September to 21 days (Goodlord).

Rents are forecast to increase by 3-4% over 2025 as slower growth in large cities is offset by faster growth in more affordable markets (Zoopla).

The average rent in October was £1,345, up 1.4% year on year (HomeLet).

### Economy

The Bank of England has held interest rates at 4% in its November meeting.

Monthly GDP grew by 0.3% in the three months to August 2025, a slight increase from 0.2% in July (ONS).

CPI inflation rose by 3.8% in the 12 months to September, unchanged from August (ONS).


