

### Local Summary

**Over the last 12 months** the average rent achieved for homes let in High Wycombe was £1,360 per month. This is a 8% change on the previous 12 month period.

57% of homes let in the past 12 months were flats, achieving an average rental value of £1,156 per month. Houses achieved an average rent of £1,726 per month.

18% of renters are aged between 40 and 49.



## National Market

### Rental market

The average void period dropped from 24 days in November to 23 days in December (Goodlord).

Rents are forecast to increase by 3-4% over 2025 as slower growth in large cities is offset by faster growth in more affordable markets (Zoopla).

The average rent in January was £1,302, up 2.4% year on year (HomeLet).

### Economy

The Bank of England has held interest rates at 3.75%, remaining at their lowest level since February 2023.

Monthly GDP is estimated to have grown by 0.3% in November, following a fall of 0.1% in October 2025 (ONS).

CPI inflation rose by 3.4% in the 12 months to December 2025, up from 3.2% in November (ONS).


